Dogs in Douglas County Must be Kept on Leash — It's the Law

Douglas County law requires that ALL dogs not on their owners' property to be on a leash at all times. Dog owners who fail to leash their pets may face a fine of at least \$50 per dog.

Douglas County offers several off-leash areas. Bayou Gulch Regional Park provides the closest area to The Pinery.

Bayou Gulch Regional Park provides 2+ acres of off-leash fun for man's best friend on the east side of Fox Sparrow Road. The dog park area is adjacent to 2.5 miles of soft-surface trails that require dogs to be on leash as a courtesy to other trail users and wildlife. The dog park is open one hour before sunrise until one hour after sunset.

Directions: Take Hwy. 83 south of Parker to Bayou Gulch Road; travel east one mile and turn north on Fox Sparrow Road. The dog park is on the right (east) side of the park. For more information please call Douglas County Parks at 720-733-6990.

Mountain View Elementary: Your Best Choice for Primary Education!

Every day, we are so proud to provide a nurturing environment focusing on what is good for young children academically, socially and emotionally. The Vision of Mountain View is to build an educational community that inspires each student to reach his or her individual potential.

This spring in Kindergarten, the students explored attributes of different objects and realized that these objects could be sorted by these properties. They applied the 21st Century skills of problem solving and reasoning by analyzing similarities and differences between objects. They also used Critical Thinking to evaluate evidence to support their position for classifying the object's attributes.

Our first grade students learned that solids and liquids have unique properties that distinguish them. They applied 21st Century Skills through problem solving to extend patterns found in the world. They also evaluated evidence to distinguish relevant and non-relevant information to support a position. They conducted ice-melting experiments to support this Physical Science Standard.

Our second grade students completed the Flat Stanley project. This project integrated the Reading, Writing and Communicating Standard along with the Geography Standard. The project also increased global awareness.

While we are in the process of providing incredible support and instruction for our current students, we are also in the midst of preparing for a new group of preschool students and kindergarteners for next year and considering how we will best meet their needs! Wildflower Project At Northeast Elementary

On **Earth Day**, students in our class took a walk outside and compared/contrasted features caused by human impact and those caused by Earth processes (nature). We discovered an area on the edge of our parking lot that has been very impacted by erosion due to loss of vegetation over time through drought. Students wrote proposals to Mrs. Tynecki to ask if we could plant wildflowers in this area--both to decrease erosion and to encourage pollinators in our schoolyard environment---something we learned are in short supply here in our Citizen Science study earlier in the year.

This kind of environmental awareness is important for elementary age students to connect them to their (natural) world, to build understanding of the issues impacting our environment, and to give them an authentic vehicle to improve and sustain the environment.

On May 19, we turned over and amended the soil, then planted deer resistant varieties of wildflower seed. Now, we're waiting for our seedlings to appear!

One letter written by students:

Dear Mrs. Tynecki,

Ms. West's class would like to have permission to help the environment by planting wildflowers by the east end of the parking lot entrance. This will help attract pollinators and stop erosion. It would make a good impression on newcomers in our community. These flowers will also teach students, teachers, and our community more about science and nature. It will set an example for others to help nature, pollinators, and the environment. This could also create an area for research where others can learn. There is currently some damage, but we will gladly place fresh soil where erosion has occurred. These flowers will be quite beautiful and gorgeous. Clearly, we are asking your permission and support to create this wonderful area.

Pinery Garden Club Happenings

This spring we have experienced unpredictable weather. Mother Nature has been fierce with late season snowstorms, frequent hailstorms and lots of rain. One thing about Mother Nature is that she does not discriminate. She does not care if you are a novice or expert gardener. Everyone has to contend with what she dishes out. This was evident when we went on our first garden club outing to Iris4U Garden in Denver.



Due to the torrential rains last September, the dry spells early in the year and recent hailstorms, the iris blooms were not as showy as in years past. We saw some plants whose growth had been stunted and did not have blossoms and others which had been damaged by hail. Still there were beautiful specimens to behold in various shades of purple, oranges, pinks, yellows and white.

Because, the club was allowed to visit prior to the public, we had the undivided attention of “Iris Bob”, the owner. Between Bob and our own club garden expert, John; we received a wealth of information about irises, including:

1. Irises actually set their flowers the year before the blooms appear.
2. Although color is very important, some blooms are excellent specimens because of other factors such as having lots of ruffles on the petals.
3. When you divide iris, remove the bloom-stalk because it will never bloom again.
4. You should divide iris rhizomes every 3 to 4 years.

- Chihuly at the Botanic Gardens
The Denver Botanic Gardens is hosting world-renowned glass artist – Dale Chihuly. The cost is \$15 for adults and \$12 for those over 65 (group rates are cheaper if we have 10 people confirmed). We are trying to arrange a behind the scenes tour of this spectacular exhibit!

Found an Orphaned or Injured Baby Wild Animal?

How to tell if baby animals are orphaned, injured, or perfectly fine—and what to do if they need your help

It's common to see baby wild animals outside during spring, as a new generation makes its way into the world. Unless the animal appears injured or in distress, there may be no need to rescue them.

People often mistakenly assume that a baby deer (a fawn) is orphaned when found alone. If he is calm and quiet, he is OK, and his mother deer (the doe) is probably nearby. A doe only visits and nurses her fawn a few times a day to avoid attracting predators. Unless you know the mother is dead, leave the fawn alone.

Mother deer are wary of human smells, so if you have already handled the fawn, take a towel, rub it in the grass, and then wipe

down the fawn to remove all human scent. Then return the fawn to the place where you found him.

Only if the fawn is lying on his side, or wandering and crying incessantly, is he likely to need help. If this is the case, contact a licensed wildlife rehabilitator. To find a rehabilitator, contact Colorado Parks and Wildlife (<http://cpw.state.co.us>).

2014 Architectural Review Committee Election Results

The ARC Election was held as a part of the May 14 General Meeting. The four candidates who came forward for the four open two-year terms were elected. They are as follows: John Grissom, Raymond Guth, Nicola Lund (Incumbent), and Brent Marsh (Incumbent).

We want to thank these homeowners in advance for their service to the community. We also want to thank Robert Neyens, whose term has just completed, for his service on the Committee.

Need to Repaint?

To blend buildings as much as possible with our beautiful natural environment covenants require all structures in the Pinery to be in earth tones indigenous to the area. This covenant restriction is a primary factor in the unique character of the Pinery. A sample board of approved shades is available in the Pinery HOA office. **Some colors not allowed are white, black, red, blue, yellow, purple, orange and pink.**

Submittal for architectural review is not required if repainting using the same colors previ-

ously approved by the Architectural Review Committee. If your current colors pre-date your ownership or you are in any way unsure of the approval status of the colors on your house (e.g., if you don't have an ARC approval letter on file), please submit samples of the colors prior to repainting. Re-application of an unapproved color or represents a new violation, with appropriate ARC enforcement.

If changing colors, samples must be submitted to the ARC for review.

For shades which clearly appear within the range presented by the office color board, the ARC administrator can confirm the colors to be pre-approved. You can at this point begin painting, the change will be noted by the ARC at the subsequent meeting, and you will get a confirmation letter for your files.

If there is any question as to whether or not a color falls within the desired earth tone range, color chips submitted will be reviewed by the ARC at the subsequent meeting. **Be sure to have confirmation of ARC approval; either verbally if pre-approved or, through an ARC approval letter as described above before painting begins!**

Residents will occasionally tell of homes which they've seen that clearly are not within the approved range. It may well be that the property has a *Notice of Covenant Violation* on file with the Douglas County Clerk and recorder, pending correction. For more information on this process, see the Pinery Architectural Standards, available in our office or at www.pinery.org. The *Public Notice of Policy Statement* on page 11 describes this process which has been adopted to minimize costs while ensuring eventual compliance for this and other types of Covenant violations.

Fencing

In order to maintain the open space environment characteristic of the Pinery, use of split rail fencing is encouraged where fencing is needed. Where containment of animals or small children is the goal, 2" x4" welded wire may be used on the inside of the fence, not to exceed the top rail, to ground level.

Placement of the fence should be at or within setbacks specified in the "Dwelling, Construction, and Fence Restrictions" in the applicable Pinery Protective Covenants.

Submittal for architectural review should include at minimum:

- Plot plan for property showing:
 - Location of existing dwelling
 - Location of property lines and easements
 - Location of proposed fence
 - Measurements between all of the above
 - Drawing of proposed fence including location and width of gates (48" maximum)
- Description of fence material (e.g. 2-rail split rail with 2" x4" welded wire).
- Signatures of affected neighbors to indicate that they are aware of the proposed change, the meeting date, and time the plan will be presented to the ARC.

In order to facilitate planting of seasonal vegetable gardens only, the Architectural Review Committee will allow an exception to the prohibition against wire mesh fencing within the following parameters:

- Work with adjacent neighbors to ensure views are not adversely affected
- Contact the Utility Notification Center of Colorado 1-

800-922-1987 for locates before any digging takes place

- *Fence to be installed only during the growing season; not installed prior to April 15 / removed no later than October 15. Fence materials stored out of view when not in use.*
- Materials used should be selected so that the visibility of the fence is minimized:
- Fence no taller than 6'
- Use 2" x4" welded wire
- Narrow posts, also no taller than 6', such as the 6' studded T-post available for utility fences.

Please ensure your seasonal fence meets these requirements!

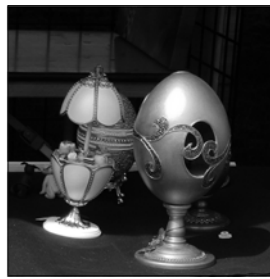

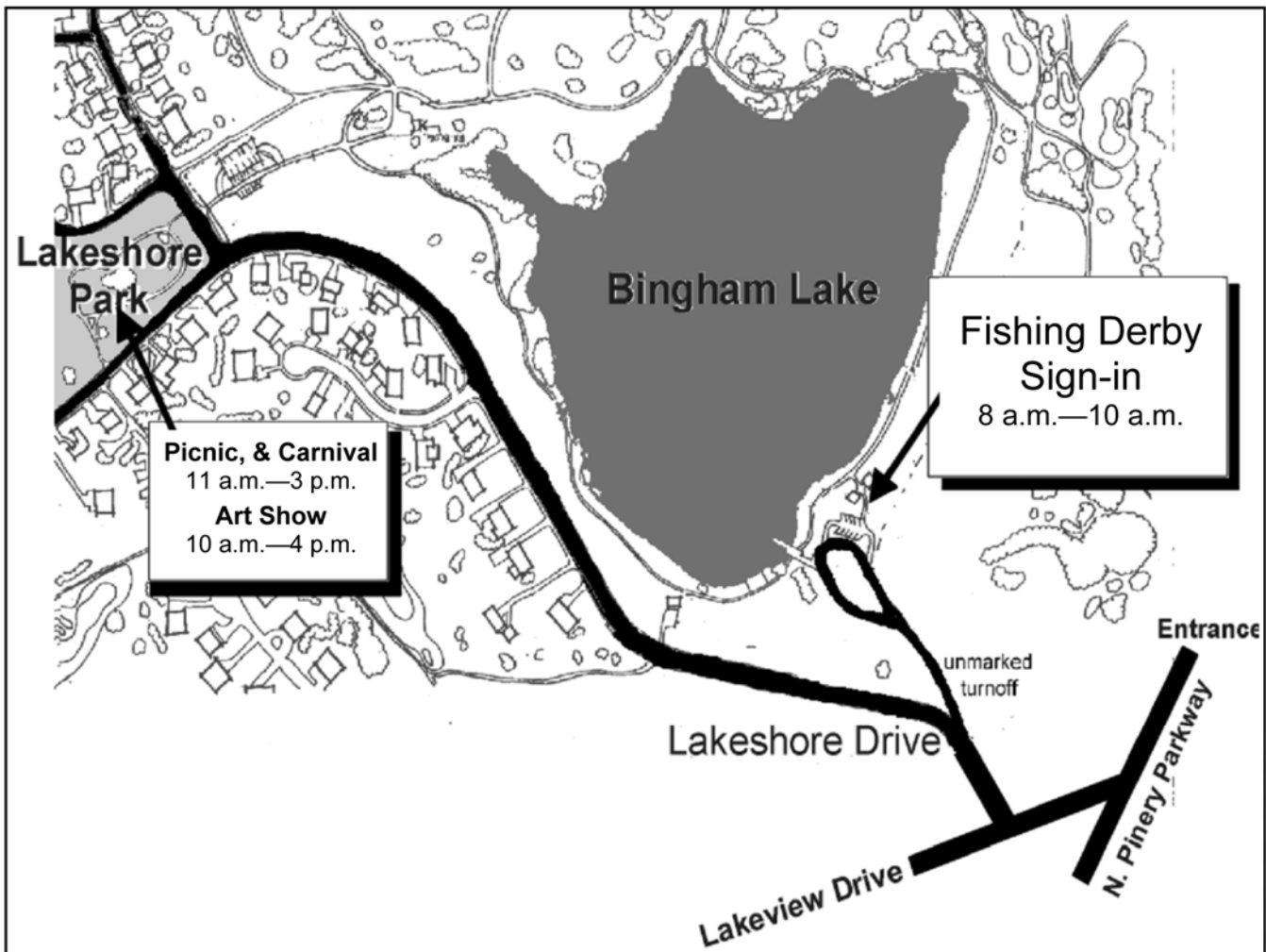

Open to residents of Douglas County

Acceptable Items: oil-based paint and paint products, automotive fluids, antifreeze, vehicle and household batteries, house and garden chemicals, fluorescent light bulbs, CFLs, fuels, items containing mercury, propane tanks, and car and pickup truck tires (remove from rim).

Unacceptable Items: business and commercial waste, radioactive waste, electronic waste (computers, TVs, etc.), explosive waste, smoke detectors, scrap metal, oil drums, asbestos, medical waste or any compressed gases other than propane.

You will need: a driver's license, water bill, utility bill or phone bill as proof of residency.

Cost: A contribution of \$25 per vehicle is requested to help offset the high cost of hazardous waste disposal.

Latex Paint Disposal Tips:

- Water-based latex paint is **NOT** a hazardous waste, and can be safely disposed of with your regular household garbage once it is dried out and no longer liquid
- Mix the paint with kitty litter, dirt or sand to help it dry out and solidify
- Break the top layer and stir so that wet paint underneath can dry faster

- Dried-out cans of paint with the lid off can be discarded in household trash

If you are not in the Pinery Trash Program, you might want to consider joining with the over 1500 other participating homeowners. The program offers state of the art trash service including Single Stream Recycling. This provides you, with the opportunity to put paper and other recyclables together into a labeled container (we provide the labels) of your choice. Recycling must be separated from your regular household trash, but the recycling center now separates the paper from the bottles, cans, etc. You may choose to use a container with wheels and a lid for ease of handling.

In addition, our program includes the removal of one Large or Bulk Item every month. Give Waste Management a call, set the item out with your regular household trash and say goodbye. That's twelve times a year you can get rid of a sofa bed, mattress, chair or other item without additional charges. If you have more than one item in a month low rates are offered.

AGREEMENT

By submitting this enrollment form with initial payment, the above Pinery resident and/or homeowner ("Homeowner") hereby authorizes The Pinery Homeowners' Association, Inc. ("PHA") to engage its contracted trash service to collect and dispose of Homeowner's normal household waste materials at the above described Pinery residence. Homeowner warrants that all waste materials offered for collection will not contain any hazardous, toxic or radioactive wastes or substances as defined by applicable federal, state or local laws or regulations. Homeowner agrees to pay PHA in advance within 15 days of billing for trash service at the PHA's then current rates until such time as Homeowner notifies PHA of Homeowner's termination from the PHA trash program. Failure to pay as specified which results in rebilling and/or termination will incur fees to cover the PHA cost of these actions. Homeowner shall be solely responsible to the contracted trash service for any additional services requested which are not included in PHA's normal trash program. Homeowner acknowledges and agrees:

1) that PHA is merely acting as a billing agent for the contracted trash service; 2) that Homeowner shall not receive any refund upon termination of Homeowner's participation in PHA trash program unless Homeowner provides advance notice to PHA, including address to which refund should be sent; and 3) that PHA will not be liable for any act or failure to act on the part of the contracted trash service, including, without limitation, violation of laws or regulations, injury or death to persons or animals and loss or damage to property or the environment.
