The Pinery Architectural Review Committee



The Pinery Architectural Review Committee continues its efforts to work with residents so that changes to properties are Covenant compliant. The Committee enjoys getting to know our neighbors in this way. The ARC also provides assistance to bring properties into compliance where violations are present.

The ARC is comprised of seven members who are elected for alternate two-year terms. Election for three or four positions is held during the May PHA General meeting. The ARC meets the second Tuesday of every month at 6:30 pm. In the Community Room of the Pinery Fire Station, unless otherwise announced via this newsletter or at www.pinery.org. The ARC has responsibility for Pinery Filings 1 through 8A (including Pinery Estates) and Fairway Ridge, almost 1900 properties.

The committee serves without compensation with a part-time paid staff person. ARC office hours are Tuesday through Thursday 8 a.m. to 3 p.m. The office is also staffed on Fridays prior to ARC meetings.

In an effort to address homeowner issues as quickly as possible at meetings, homeowner submittals, received by noon on Friday prior to the meetings, are reviewed beginning at 6:30 p.m. Review of any new construction plans begin at 7:30 p.m. or when homeowner reviews are concluded. Submittals received after noon on the Friday are heard after other issues are discussed at the meeting.



PHA Trash Program Enrollment Form

If you are not in the Pinery Trash Program, you might want to consider joining with the over 1500 other participating homeowners. The program offers state of the art trash service including Single Stream Recycling. This provides you, with the opportunity to put paper and other recyclables together into a labeled container (we provide the labels) of your choice. Recycling must be separated from your regular household trash, but the recycling center now separates the paper from the bottles, cans, etc. You may choose to use a container with wheels and a lid for ease of handling.

In addition, our program includes the removal of one Large or Bulk Item every month. Give Waste Management a call, set the item out with your regular household trash and say goodbye. Douglas County Emergency Notification System—CodeRED

ife can change in a moment - make sure you are connected to the CodeRED emergency notification system in Douglas County! The system, CodeRED, is a high-speed telephone emergency notification service allowing public safety agencies the ability to deliver pre-recorded information to targeted areas within the county.

Douglas County's public safety agencies encourage everyone to register their contact information in the CodeRED system (reverse 911). Registration is not automatic, but it may be critical to your safety and that of your family.

Cigarette Butts - fire hazard and environmental issue

You may think that there are no consequences to tossing a cigarette butt out of your car window but here are a few facts:

- Cigarette butts are the most commonly discarded piece of waste worldwide. It is estimated that **1.69 BILLION pounds** of butts wind up as toxic trash each year, creating an enormous environmental, health, and economic burden.
- Contrary to popular belief, cigarette butts are NOT biodegradable! Cigarette butt waste is a significant environmental issue, with a global impact—it is both unsightly and unhealthy.
- Hot, dry and windy weather conditions dramatically increase the fire risk. A single burning butt can do much damage.

Please keep your butts in the car so that they can be appropriately and safely disposed of.

Timbers Development

Construction has commenced on Filing 32 of the Timbers. This is the area that lies just to the north of North Pinery Parkway and east of Ponderosa Way. Pinery residents may feel that the changes being made near their homes does not reflect plans on paper. The Timbers development started over twenty years ago and has held quite true to the original plans approved by the county, which addressed concerns expressed by the Pinery Homeowners' Association. Filing 32 has seen changes based on input from our residents bordering the development. Those include:

- The "no build" or "buffer" space between The Pinery and new development was increased from the Douglas County approved 50 ft. for this area, to a minimum of 100 ft.
- Location of lots were moved away from The Pinery boundary
- Building envelopes widen the no build area towards the boundaries
- The detention pond, originally located close to The Pinery boundary, was relocated to the center of filing 32. The relocation also was a result of new county and state standards.

Other changes to the plans are related to State and County development requirements:

- Fire mitigation impact on tree preservation: The tree preservation plan that was implemented as part of the approved development over 20 years ago is still followed today. It is monitored and enforced by Douglas County. Over time, there have been some changes due to fire mitigation requirements that were not in place when the plans were originally approved. Tree branches are trimmed up ten feet. Areas under the trees must be clear of any shrubs such as gamble oak (i.e. scrub oak). If there are more than 4 trees closely clumped together, the weakest tree will be removed. Efforts are made to move these trees however if the roots are intertwined, this is not possible, requiring the removal of the tree.
- Life safety requirements are a critical part of design in any development. SouthMetro Fire has extensive planning requirements to ensure residents can be quickly reached or evacuated in times of emergencies. Those include but are not limited to access for first responders, i.e. medical emergency, fire protection, and law enforcement. Road design, and connectivity are affected by these requirements.

Other trees are being removed as planned, to make way for streets and will also be removed within the approved building envelope as home construction progresses. In keeping with the tree preservation plan, trees which can be relocated are being moved rather than cut down. Landscaping will be restored when construction is complete and added trees will be a part of that.

The work being done follows the plans approved by Douglas County Commissioners, Planning and South Metro Fire District. Pinery residents have had several opportunities to review plans over the past years. Residents bordering the development were each contacted in writing last year, giving the opportunity to comment and share concerns with the county. Those comments/concerns are passed onto the developer for review and to implement changes.

Note that noise from construction work is allowed from 7 a.m. to 7 p.m.

The Timbers is beginning work that includes deep trenchwork in soil that is not compacted.

For your safety, please stay out of construction areas!

Neighborhood Watch

The police can't keep your neighborhood safe and crime free without your help. After all, no one knows more about what's happening in your neighborhood than you. We depend on you to share that information with us and your neighbors when appropriate.

We'll teach your NW how to prevent crime, let you know about crime trends, and will take action when appropriate.

We'll also help you prepare for, survive and recover from natural and manmade disasters.

You may also request a House Watch, which will notify the Sheriff's Office that your house will be unoccupied for a short duration.

Recycling: Keep It Simple

We know that life can be complicated. When it comes to recycling, we want to keep things simple. If you follow these three simple rules, you will make a big difference in recycling.

- Recycle empty bottles, aluminum cans, clean paper and cardboard. Focus on these key items and you will make a big difference. If it's not a bottle, can, paper or cardboard, it doesn't belong in your curbside recycling cart.
- 2. **Keep food and liquids out of recycling**. A halfempty bottle of ketchup can ruin a load of cardboard. Contaminated materials end up in the landfill, instead of getting recycled into useful new products. Bottles and cans should be empty and clean. Paper and cardboard should be dry and free of any food residue. Greasy pizza boxes go in the trash.
- 3. Do not bag recyclables or put plastic bags in your recycling. Bags and other plastic film, including food wrap and packaging material, get tangled in recycling equipment and bring operations to a halt. If you collect your recyclables in plastic bags, please empty the bags directly into your recycling cart. Place soiled plastic bags in your trash; return clean bags to a retailer for recycling.

It's Okay to Start Small

If you get overwhelmed by what's recyclable and what's not, start with one item. Do you use a lot of canned food? Start with cans. Perhaps you go through cases of bottled water. Focus on getting all the empty plastic bottles into the bin. It's better to do a great job with one recyclable item than to risk ruining a load by mixing in non-recyclables.

Take the <u>Recycle Often Recycle Right</u> pledge and vow to do your part. Encourage your family and friends to do participate, too! By following the three rules, we will send our recyclable items to their next beneficial use and keep valuable resources out of the landfill.

Feeding Wildlife Puts Everyone at Risk

Olorado is blessed with a diversity of wildlife. Our elk population is larger than that of any other state or Canadian province. In addition, our state is home to an abundant, thriving deer population.

The Colorado Parks and Wildlife—whose mission is to protect and enhance the state's wild creatures—knows how much people love Colorado wildlife. They love to watch the animals, learn about them, photograph them, hunt them and, on occasion, even feed them.

We know people mean well when they give tidbits to wildlife. What many don't realize is that feeding big game is bad for the animals and dangerous for people. It's also against the law. There are lots of good reasons why.

While putting out food for animals like foxes and deer seems harmless, repercussions can be disastrous. Please don't feed the wildlife!

Feeding Wildlife: More Harm Than Good

It is illegal in Colorado to intentionally place or distribute feed, salt blocks or other attractants for big-game animals. This problem is mainly associated with deer.

In the winter, deer herds tend to move to lower elevations closer to homes and businesses. Some people may feel the deer do not have adequate food sources in the wintertime and believe that supplementing their diets with grain, corn or hay is helpful. In fact, the contrary is true. "People who feed deer do more harm than good," says Trina Lynch, a district wildlife manager with the Colorado Parks and Wildlife.

The Colorado Parks and Wildlife launches controlled, emergency feeding of big-game animals only during extremely harsh winters when substantial numbers of animals are threatened. In all other cases, big-game animals are better off left to obtain their food naturally.

Unwanted and Dangerous Guests

According to Lynch, there are several reasons why a Colorado law passed in 1992 makes it illegal to feed big game animals. One important reason is that deer are the primary prey of mountain lions. "Concentrating deer by feeding can attract mountain lions well within the city limits. It may become necessary to kill these lions for public safety," she says.

Disease

Concentrating deer by feeding them can also increase stress on the deer and hasten the spread of disease. Diseases can spread between wildlife and livestock, as well as to domestic animals and people. CPW is most concerned about devastating diseases, such as brucellosis and tuberculosis, which can be transmitted to humans.

Health

We all know junk food is bad for people, but it's even worse for wild animals. Deer, elk, and pronghorn are ruminants. That means they have a four-chambered stomach that serves as a 'fermentation vat'. They can eat lots of vegetation and digest it very thoroughly.

"Habituation to artificial feeds that do not meet their nutritional needs often results in deer that are in poor condition," explains Bob Davies, a wildlife biologist in Colorado Springs. Unlike natural foods, treats from people often cannot be digested properly by big game. In fact, "human food" can stop a wild animal's digestive system, causing it to get sick and die.

Big game depend entirely on native vegetation, such as grasses, forbs, and shrubs. Those plants provide all the nutritional requirements the animals need to survive in Colorado, even through winter. Eating non-natural kinds of foods can result in nutritional problems for wildlife, or even death.

Although commercial feeds are available at many stores, Colorado Parks and Wildlife biologists warn against using them. "Some of these products may indicate they will attract certain wildlife species, including deer," says Davies. "People should be aware that if they place feed out and deer consume it, they may be breaking the law. Fortunately, once people learn about the negative impacts that occur when deer are fed, most stop doing it," he says.

Deer and Garden Damage

People who attract deer to their neighborhood also run the

risk of damaging their property and their neighbor's property. "Some people are under the impression that if they supply a food source to the deer it will prevent the deer from damaging their ornamental plants. On the contrary," says Lynch; "it usually results in greater damage to your plants."

Instead, Lynch recommends:

- barriers
- repellents
- landscaping with native plants

The Law

Under Colorado law, intentionally feeding big game animals is illegal. The prohibition applies to deer, elk, pronghorn, mountain goats, bighorn sheep, mountain lions, and bears. Violators face a \$50 fine.

Colorado Parks and Wildlife hopes you won't face such a fine and that we've explained why it's best to simply let Mother Nature take care of wild animals. If you don't, you quite literally could end up loving our wildlife to death.

Open to residents of Douglas County

Acceptable Items: oil-based paint and paint products, automotive fluids, antifreeze, vehicle and household batteries, house and garden chemicals, fluorescent light bulbs, CFLs, fuels, items containing mercury, propane tanks, and car and pickup truck tires (remove from rim).

<u>Unacceptable Items</u>: business and commercial waste, radioactive waste, electronic waste (computers, TVs, etc.), explosive waste, smoke detectors, scrap metal, oil drums, asbestos, medical waste or any compressed gases other than propane.

<u>You will need</u>: a driver's license, water bill, utility bill or phone bill as proof of residency.

<u>Cost</u>: A contribution of \$25 per vehicle is requested to help offset the high cost of hazardous waste disposal.

Latex Paint Disposal Tips:

- Water-based latex paint is <u>NOT</u> a hazardous waste, and can be safely disposed of with your regular household garbage once it is dried out and no longer liquid.
- Mix the paint with kitty litter, dirt or sand to help it dry out and solidify.
- Break the top layer and stir so that wet paint underneath can dry faster.
- Dried-out cans of paint with the lid off can be discarded in household trash.
